OFFICE ORDER



TERMS AND CONDITIONS

- 01 He shall have to produce a Medical Fitness Certificate of his fitness duly signed by the Chief Medical Officer/Medical Officer before joining to the post.
- 02 He is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices/Institutes.
- 03 He shall have to take an oath of allegiance/faithfulness to the Constitution of India.
- 04 The appointment may be terminated at any time by one month notice given by either side viz. the appointee or appointing authority, without assigning any reason. The appointing authority however reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice of the un-expired portion thereof.
- 05 He is required to produce a certificate of character issued by Sub-Divisional Magistrate or from the Gazetted Officer known to him for the last three years before joining the appointment.

- 06 He shall have to submit a declaration to the effect that he has one living spouse, if married.
- 07 If any declaration given or information furnished/supplied by him proves to be false or is found to have willfully suppressed any material/information he will be liable for removal from the service and for such action as the Govt. may think necessary.
- 08 The services rendered on contract basis shall not be counted towards qualifying service and pensionary benefits etc. He shall be entitled to regular scale of pay and seniority as Workshop Instructor from the date of his joining on regular basis.
- 09 The official(s) shall be on probation for a period of two years which can be extended, if so warranted.
- 10 The appointment shall be governed under Himachal Pradesh Civil Service Contributory Pension Rules, 2006.
- 11 The appointee shall have to submit the nomination of the Group Insurance Scheme, 1984 at the time of joining of duty.
- 12 No TA/DA will be admissible for joining the duty.

If the offer is acceptable to the candidate on the terms and conditions mentioned as above, he may join duties at his place of posting within 15 days from the issue of these orders failing which the offer shall be treated as withdrawn.


