1. India has applied for financing from the Asian Development Bank (ADB) towards the cost of “Himachal Pradesh Skill Development Project” and it intends to apply part of the proceeds of this financing to the payment under the Contract Package named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The “Directorate of Technical Education, Vocational and Industrial Training, Himachal Pradesh”, represented by the Director (“the Purchaser”) invites sealed bids from eligible Bidders for the Supply of **Furniture and related equipments** for Industrial Training Institutes.
3. **National Competitive Bidding** will be conducted in accordance with ADB’s Single-stage: Two-envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - a) Successful completion as main supplier within the last three (3) years, at least One (1) contract valued at **INR 30 million** with similar nature, and complexity.
 - b) Minimum average annual turnover of **INR 75 million** calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.

However, for complete eligibility and qualification requirements, bid document should be referred.
