In regard to this it is most humbly submitted that the complaint by the Class-IV employees is the likely outcome of my office Note Dated: 15.12.2023 vide which I had informed to your good office regarding the Class-IV employees in the institute discharging their duties without wearing the prescribed uniform. Itwas requested to issue them necessary direction to come in the institution wearing prescribed uniform failing which the washing allowance being given to them may be withdrawn. I never used any threatening language verbal/written neither for any Class-IV employee nor my subordinates. The lodging of complaint levelling false and furbulous allegations against me was nothing but a mean way to express their anger. Knowing the fact that the Class-IV employees must be much annoyed with me you still constituted a committee to enquire into the false allegations levelled against me bythem. Instead of ensuring maintaining of the right decorum in the office they have now been given the impression of being right all the times. Resultantlynon of them is bothered to wear the uniform which was the only intention on my part. Apart from that they now feel themselves free to create any indiscipline in the institute or do any nuisancethey like. It is therefore requested that instead of going with the ulterior motives of a few employees with vested interestsplease support the voices that are meant for the betterment of the institute always.
