Shri Mohinder Singh, Principal, Government Industrial Training Institute, Baroh, Distt. Kangra, HP had moved to Hon'ble High Court, HP vide CWP No. 2705/2020 titled as Mohinder Singh Vs State of HP and another for seeking quashing of the impugned order of transfer dated 21/07/2020.

Hon'ble High Court took up this case on 27/8/2020 and passed the following order:-

"The petitioner, who is working as Principal, Government Industrial Training Institute Baroh, Distt. Kangra, HP and is under transfer to Government Industrial Training Institute, Nerwa, District Shimla, HP, has come up before this Court seeking quashing of the impugned order of transfer dated 21.7.2020. Heard learned counsel for the petitioner and learned Additional Advocate General for the respondents. In view of the nature of the order, we propose to pass, no response is required from the respondents. Consequently, this petition is disposed of with liberty to the petitioner to make representation to the first respondent, within one week, in accordance with the transfer policy. On receipt of such representation, the respondent shall consider the same, in the light of the transfer policy



occupying the field, and pass appropriate orders, within two weeks. Subject to filling of representation within the time-frame mentioned above, the interim order dated 5.8.2020, shall remain in force till the decision of the representation. Pending application(s) if any, are closed."

In pursuance to the Hon'ble High Court orders an opportunity of personal hearing was afforded to Shri Mohinder Singh, Principal on 26/10/2020 and he was heard at length on the same day. The representation of Shri Mohinder Singh, Principal as received was also examined. During personal hearing Shri Mohinder Singh, Principal stated that his 87 years old parents are residing with him and he have to look after them besides performing his own duty. He has further stated that his daughter's marriage has been fixed on April, 2021 whose responsibility is also on him, therefore he has requested to adjust him at Govt. ITI, Rajhoon, Distt. Kangra against vacancy.

Shri Mohinder Singh, Principal is holding the post of Principal which is class-I gazette post and have State cadre and is liable to be posted anywhere in the State in the larger interest of education of children studying in Government ITI's.


However, keeping in view of above and family circumstances of Shri Moinder Singh, Principal, Govt. ITI Baroh, Distt. Kangra, it has decided to adjust him as Principal, Government, ITI, Rajhoon, Distt. Kangra. Accordingly, the representation is considered and disposed off. This order be brought to the notice of all concerned.
