NOTIFICATION

The Governor, Himachal Pradesh, in exercise of powers conferred by the proviso under Section 12(1) of the Himachal Pradesh Technical University Act, 2014, is pleased to appoint Prof. Sat Parkash Bansal, MIG-17, Bansal Kunj Opp. Housing Board Godown, Housing Board Colony, Sanjauli, Shimla-171006, (Presently working as Vice-Chancellor, Indira Gandhi Haryana State University- Haryana) as Vice-Chancellor, Himachal Pradesh Technical University, Hamirpur, Himachal Pradesh from the date he enters upon his office for a period of three years or until he attains the age of 65 (Sixty Five) years, whichever is earlier with immediate effect in public interest, on the following terms and conditions:-

- The Vice-Chancellor shall be entitled to receive salary of Rs.75000/-(Seventy Five Thousand) per month fixed and allowances as notified by the State Government from time to time.
- 2. He shall be entitled, to furnished residence during his term of office at the Headquarter of the University and no charge shall be levied on the Vice-Chancellor personally in respect of the maintenance of such residence including the lawns etc.. License fee as per the norms of the State Government shall be charged from him.
- 3. The Vice-Chancellor shall be entitled to such terminal benefits as may be prescribed by the State Government from time to time including the benefit of Contributory Provident Fund.
- 4. Where a Professor of the Himachal Pradesh Technical University, Hamirpur or other Universities Established the Government of Himachal Pradesh or a College or Institution maintained by the Himachal Pradesh Technical University, Hamirpur or any other University or Institution maintained by or admitted to the privileges of such other University, is appointed as Vice-Chancellor, he shall be allowed to continue to contribute to any provident fund of which he is a member and the University shall contribute to the account of such person in that provident fund at the same rate at which the said University/College/Institution has been contribution immediately before his appointment as the Vice-Chancellor,

Sp.

- i) Provided further that where such Professor had been a member any pension and gratuity scheme, the Himachal Pradesh Technical University, Hamirpur shall make necessary contribution to such schemes.
- ii) Provided further that where Professor of any university is appointed as Vice-Chancellor, he shall be allowed to avail leave at his credit before his appointment as Vice-Chancellor. Similarly, on his relinquishing the post of the Vice-Chancellor and in the event of his re-joining his substantive post, he shall be entitled to carry the balance leave at his credit to the previous/new post.
- iii) Provided further that leave salary and pension contribution/CPF (Employer's share) contribution will be paid by the Himachal Pradesh Technical University, Hamirpur, if the Vice-Chancellor prior to his appointment was serving in the State Government/ Central Government/Union territory Administration/Local Bodies/ Public Sector Undertaking/Universities/Autonomous body etc. till he continues to subscribe to the Provident Fund of his Parent Department.
- 5. The Vice-Chancellor shall be entitled to leave travel concession, as approved by the State Government from time to time.
- 6. The Vice-Chancellor shall be entitled to the reimbursement of medical expenses incurred on his medical treatment and his family members from the Hospitals/Nursing Homes approved by the State Government.
- 7. The Vice-Chancellor shall be entitled to the reimbursement of the expenses on account of TA/DA for himself and his family members and transportation of personal effects (inclusive that of his family) from his home town to Hamirpur (Himachal Pradesh) and back on his assuming office and on the expiry of his tenure.
- 8. The Vice-Chancellor shall during the tenure of his office, be entitled to leave on full pay at the rate of 30 days in a calendar year. The leave shall be credited to his account in advance in two half-yearly instalments of 15 days each on the first day of January and the first day of July every year:
 - i) Provided that if the Vice-Chancellor assumes or relinquishes the charge of his office any time during the year, the leave shall be



credited proportionately at the rate two and a half days for each completed month of service.

- ii) The leave at the credit of the Vice-Chancellor at the close of the previous half year shall be carried forward to the next half year subject to the condition that the leave, so carried forward plus the credit for that half year, does not exceed the maximum limit of 300 days.
- iii) The Vice-Chancellor shall be entitled to encashment of the earned leave on relinquishing the charge of his office which shall be equivalent to the salary admissible for number of days of leave on full pay due to him at the time of his relinquishing the charge, subject to maximum of 300 days including encashment benefit availed elsewhere.
- iv) The Vice-Chancellor shall also be entitled to half-pay at the rate of twenty days for each completed year of service. The half-pay leave may also be availed as commuted leave on full pay on medical certificate. Provided that when such commuted leave is availed, twice the amount of half-pay leave shall be debited against the half-pay leave account.
- v) The Vice-Chancellor shall be entitled to avail extra-ordinary leave without pay for a maximum period of three months during the full term of three years on medical grounds or otherwise.
- vi) In case the Vice-Chancellor is appointed for another term, the leave entitlement period mentioned above, shall be applicable separately to each term.
- vii) During the period of such leave, the Vice-Chancellor shall be entitled to the same salary, honorarium and allowances and such other facilities of service as may have been provided.
- 9. In the case of absence occasioned by any call by the Central or State Government or Public Service or on deputation on behalf of the University for any public purpose, the period so spent shall be treated on duty.
- 10. The Vice-Chancellor shall be entitled to the facility of an attached official car and free telephone with STD facility at his residence.
- 11. The Security arrangement for the Vice-Chancellor shall be made by the University by appointment of Security Guards and no charge thereof shall be levied on the Vice-Chancellor.



- 12. The Vice-Chancellor may resign by giving notice of one month in writing under his signatures addressed to the Chancellor. The Chancellor may waive the period of notice and accept the resignation forthwith in consultation with the State Government.
- 13. The Vice-Chancellor shall be entitled to leave on full pay for one eleventh of the period spent by him on active service.
- 14. The Vice-Chancellor shall countersign his own T.A bills as per T.A. Rules.
