NOTIFICATION

The Governor, Himachal Pradesh is pleased to appoint Dr. Vinod Kumar, Professor Electronics & Communication Engineering Department, NIT Hamirpur (HP) PIN-177005 as Director/Principal of Mahatma Gandhi Govt. Engineering College Kotla (Jeori) on secondment basis for a period of 03 years from the date of assumption of the charge as such with immediate effect on the following terms & conditions:-

1. The Pay Band, Grade Pay and Basic Pay of Dr. Vinod Kumar, Professor Electronics & Communication Engineering Department, NIT Hamirpur shall be protected.
2. He will be governed by the Leave Rules, Conduct Rules, Discipline Rules, Medical Attendance Rules & T.A. /D.A. Rules etc. as are applicable to him in the NIT Hamirpur.
3. Leave Salary and Pension Contribution shall be provided by the State Government.
4. Suitable residential accommodation/HRA shall be provided to him by the Department.
5. He will be provided with an attached vehicle on usual charges.
6. Special allowance of Rs. 3000/-per month shall be provided to him.
7. Telephone facilities at his residence/office on the rates fixed by the Govt. from time to time shall be provided to him.
8. He shall be entitled for Cumulative Professional Development Allowance (CPDA) @ Rs. 3.0 lakh for every block of 3 years (Rs. 1.0 lakh per year) as is allowed vide letter No. F.No.23-1/2008-T.S.II dated 18th August, 2009 issued by the Govt. of India, Ministry of Human Resource Development, Department of Higher Education, Technical Section-II, on reimbursable basis. This is being allowed only for persons, who were



working earlier in Centrally Funded Technical Institutions, where this allowance was admissible.
