**ORDER**

The present order is being issued in pursuance to directions of Hon'ble High Court in CWP No. 4615/2021 titled as Ravinder Kumar Vs State of H.P. and Ors. The Hon'ble High Court in the said CWP on dated 30.09.2021 had directed as under:-

*"Mr. Vikas Rathore, learned Additional Advocate General submits that if any option is furnished by the petitioner, the same will be considered by the respondents. Learned counsel for the petitioner submits that the option will be submitted within two days from today. Within a week's time thereafter, the respondents to consider the same and pass appropriate orders."*


Before taking up the representation of the petitioner, it would be firstly apt to give a brief background of the petitioner's case, which is being given in succeeding paragraph.

The Petitioner, Shri Ravinder Kumar, had joined this Department as Group Instructor on 21-04-2012 at Government Industrial Training Institute, Reckong-Peo, Distt.-Kinnuar. Due to administrative reasons, Shri Ravinder Kumar, Principal was transferred from Government Industrial Training Institute Palampur, District Kangra to Government Industrial Training Institute, Killar at Pangi, District Chamba vide this Department Notification No.EDN (TE) D (5)2/2021 dated 12.08.2021. The main contention raised by the petitioner appears that he had not completed his normal tenure at

his present place of posting and also served in the tribal area.


