

Subject:- Regarding change of nomenclature of the faculty of Degree courses.
Sir,

I am directed to refer to your letter No. STV(TE)H:B(4)281/08-51252 dated 7.9.2013, No. STV(TE)H:B(2)4/07/Req.Engg/51253 dated 7.9.2013 on the subject cited above and to say that while revising pay scales and other service conditions of the teaching staff of the Government Degree Level Technical Institutions vide notification No. EDN(TE)B(1)1/2012 dated 15th September, 2012 for regular incumbents, it has been provided to re-designate Lecturers as Assistant Professor in the pay band of Rs. 15600-39100 +6000AGP and Assistant Professors as Associate Professors in the pay band of Rs. 37400-67000+9000AGP. The matter has been examined in consultation with the Finance Department and it is clarified that there seems to be no reason to deny the re-designation of the post to the contract appointees, as the service conditions of contract appointees are also governed by the same set of rules as is applicable to regular incumbents except the provisions contained in the Rule 15-A (terms & conditions of contract appointees) and the AICTE norms provide for change of nomenclature in the same pay scale.

You are, therefore, requested to dispose of the proposal in consonance with notification of even no. dated 15-9-2012 please. The Contract basis incumbents may also be re-designated on the analogy of regular incumbents on the fixed contractual amount meant for the posts accordingly.
