Subject:- Regarding pay scale/change of nomenclature of the faculty
(Assistant Professors) of Degree level technical institutions
recruited in pre-revised pay scale of Rs. 12000-18300-
Clarification thereof.

Sir,

I am directed to refer to this Department's letter of even no. dated 22.05.2014 on the subject cited above and to say that various representations were received from the incumbents, who were appointed on contract or regular basis in Degree level technical institutions in pre-revised pay scale of Rs. 12,000-18300, regarding change of nomenclature of posts of Assistant Professors to Associate Professors and to place them in respective cadre/pay band of Rs. 37400-67000+9000 Grade Pay in consonance with notification of even no. dated 15.09.2012. The matter was taken up with the Finance Department (Regulations), who have observed as under:-

"Examined in FD. AD is advised to take action on the following lines:-

(i) *The Contractual amount for the post of Assistant Professor working in Engineering Colleges in Himachal Pradesh would now be Rs. 35,000 irrespective of their AGP.*


(ii) *The Contractual appointee is not entitled for pay band of Rs. 37400-67000+9000 Grade Pay as the norms prescribed by AICTE are applicable to regular appointees.*

(iii) The Contractual period will not be counted for grant of higher pay band and the incumbents will be granted next scale after completion of 9 years of service on regular basis only.

(iv) After coming into force the AICTE norms, no post of Assistant Professor will be filled up in the grade pay of Rs. 8000/-."

You are therefore, requested to take further necessary action in the matter accordingly.


