OFFICE ORDER

In pursuance to the instructions contained in the letter No. PER(AP)-C-B(2)2/2015 dated 22/04/2016 of the Additional Chief Secretary (Personnel) to the Government of Himachal Pradesh and as per the recommendations of the Departmental Screening Committee constituted at Directorate level, the services of the following Craft Instructor (Engineering / Non- Engineering) appointed on Contract Basis are hereby regularized after taking into consideration their 05 years (as on 31/03/2016) continuous service rendered on Contract Basis as Craft Instructor (Engineering/ Non-Engineering) with immediate effect in the pay scale of **Rs. 10300-34800 plus 3800/- Grade Pay** of the minimum pay in the pay band of **Rs. 10790 plus 3800 Grade Pay (Rs. 14590/-)** and other allowances admissible from time to time subject to the terms and conditions mentioned below:-



TERMS AND CONDITIONS:

- 1 He/she shall have to produce a Medical Fitness Certificate of his/ her fitness duly signed by the Chief Medical officer/Medical Officer of the area, before joining to the post.
- 2 He/she shall have to produce the original certificates of his/her academic/technical qualifications, age proof, character, etc. in original at the time of joining the Post.
- 3 He/she is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices /Institutions.

4. He/she shall have to take an oath of Allegiance/Faithfulness to the Constitution of India.
5. The appointment may be terminated at any time by one month notice given by either side viz. the appointee or appointing authority, without assigning any reason. The appointing authority however reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice of the un-expired portion thereof.
6. He/she is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to her for the last three years before joining the appointment.
7. He/she shall have to submit a declaration to the effect that he/she has one living spouse, if married.
8. If any declaration given or information furnished/ supplied by her proves to be false or she is found to have willfully suppressed any material/ information she will be liable for removal from the service and for such action as the Govt. may think necessary.
9. The services rendered on contract basis shall not be counted towards qualifying service and pensionary benefits etc. He/she shall be entitled to regular scale of pay and seniority as Clerk from the date of her joining on regular basis.
10. The officials shall be on probation for a period of two years which can be extended, if so warranted.
11. The appointment shall be governed under Himachal Pradesh Civil Service Contributory Pension Rule, 2006.
12. The appointee shall have to submit the nomination of the Group Insurance Scheme, 1984 at the time of joining of duty.
13. No TA/DA will be admissible for joining the duty.
14. If the offer is acceptable to the candidate on the terms and conditions mentioned above, he/she may join service at his/her place of posting within 15 days from the issue of these orders failing which the offer shall be treated as withdrawn.


