 - (ii) These shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

Rules.

2. The number of posts, classification, pay scale, qualification and method of Recruitment etc., for the post of Instructor Bleaching, Dying & Frinting shall be as specified in the Annexure "A".

Repeal and Saving.

The Recruitment and Promotion Rules for the post of Instructor Bleaching, Dying & Printing notified vide Industries Department Notification No.1-150/6 SI (Estt.), dated 23rd Jan., 1970 are hereby repealed.
