(I) CONCEPT

- (a) Under this policy the Library Attendant / Laboratory Attendant in Department of Technical Education H.P. will be engaged on contract basis initially for one year, which may be extendable for two more years on year to year basis.
- (b) POST FALLS OUT OF PURVIEW Of H.P.PSC/ H.P.SSS Board: Director, Technical Education after obtaining the approval of the Government to fill up the posts on contract basis will advertise the details of the vacant posts in atleast two leading newspapers and invite applications from candidates having the prescribed qualification and fulfilling the other eligibility conditions as prescribed in these rules.

(c) The selection will be made in accordance with the eligibility conditions prescribed in these Rules.

(d) Contract appointee so selected under these Rules will not have any right to claim for regularization or permanent absorption in the Government job.

(II) CONTRACTUAL EMOLUMENTS:

The Library Attendant/ Laboratory Attendant appointed on contract basis will be paid consolidated fixed contractual amount Rs. 3930/- (which shall be equal to initial of the pay scale + Dearness pay). An amount of Rs. 100/- (equal to annual increase in the pay scale of the post) as per annual increase in contractual emoluments for the second and third years respectively will be allowed if contract is extended beyond one year.

(III) APPOINTING/DISCIPLINARY AUTHORITY:

The Director (Tech. Edu.) H.P. will be appointing and disciplinary authority.

(IV) SELECTION PROCESS:


