Whereas Ms. Neelam Guleria, Lecturer (Applied Sciences & Humanities) Physics was appointed on contract basis in Government Polytechnic Kullu in the Technical Education Department vide this Department notification No. EDN(TE)B(1)1/2015 dated 10.03.2015 on the basis of recommendations of the HP Public Service Commission, Shimla.

And whereas said Ms. Neelam Guleria, Lecturer (Applied Sciences & Humanities) Physics on contract basis, working in Government Polytechnic Kullu has requested for acceptance of his resignation from the service due to his selection/appointment as Assistant Professor (Applied Sciences & Humanities) Physics in Mahatma Gandhi Government Engineering College Kotla (Jeori) camp at Sundernagar, in Department of Technical Education.

Whereas being contract appointee, matter of resignation and subsequent acceptance thereof is inconsequential.
