Terms and Conditions for the above Building Works Committee will be as under:-

1) The committee will:-

- a. Supervise strategic planning in relation to building, interior furnishing etc. in accordance with the institutional objectives.
- b. Sort out inter-department issues so that bottlenecks/irritants, if any, during the construction can be resolved at the earliest.
- c. Undertake joint inspection and execution of work quality.
- d. Exercise such powers as may be entrusted by Board of Governors Hydro Engineering College from time to time.
- e. Take appropriate action, if in the opinion of the Chairman, Building Work Committee and the Member Secretary, Director-cum-Principal Hydro Engineering College, Bandla(Bilaspur), any emergency has arisen which requires immediate action to be taken and report the same to Building Work Committee and Board of Governors Hydro Engineering College in the forthcoming meeting.
- f. Ensure that construction is carried out as per the set milestones and in a time bound manner and that timelines are being met.

- g. Approve deviation & to allow substitute and extra items required at site & same may then be got approved from Board of Governors in next meeting.
  - h. Co-ordinate between the Executing Agencies, the Directorate of Technical Education and the State Government.
  - i. Meet quarterly to discuss and finalize the matters related to various construction activities.
  - j. The report of the meetings shall be sent to the Government accordingly.
- 2) The attendance of two third of the members shall be compulsory for a successful quorum.
  - 3) The members of the committee will be entitled for TA/DA as per instructions of the Department of Finance, Government of Himachal Pradesh.
  - 4) Any other expert as may be deemed fit may be called as Special Invitee(s) to advise the committee on selected issues.
