## **NOTIFICATION**

The Governor, Himachal Pradesh in compliance to this Department's notification No. EDN(TE)B(1)2/2015 dated 03-10-2015, further clarification dated 21-10-2015 is pleased to take over the services of Smt. Nutan appointed under Students Welfare Fund in Atal Bihari Vajpayee Govt. Institute of Engineering & Technology, Pragatinagar, Distt. Shimla as Assistant Professor (Management) on contract basis, in the Department of Technical Education Vocational & Industrial Training, Himachal Pradesh in the public interest, with immediate effect, subject to condition that no senior eligible candidates is/are not left for taking over services on contract basis and also on the terms and conditions depicted below:-

- i) The above contractual appointee will be paid fixed contractual amount @ Rs. 35000/- P.M. No other allied benefits such as senior /selection scales etc. will be given.
- ii) The services of the contractual appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- iii) Contractual appointee will be entitled to one day's casual leave after putting one month service. However, the contract employee will also be entitled for 180 days Maternity Leave (in case of female appointee) and 10 day's Medical Leave and 5 days special leave. He/ She shall not be entitled for Medical Re-imbursement and LTC etc. No leave of any kind except above is admissible to the contractual appointee. Provided that the un-availed Casual Leave and Medical Leave can be accumulated up to the Calendar Year and will not be carried forward for the next Calendar Year.
- Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. Contractual appointee shall not be entitled for contractual amount for the period of absence from duty.
- v) The above official appointed on contract basis who has completed three years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
- vi) The candidate will have to submit a certificate of his/ her fitness from a Government/ Registered Medical Practitioner. Women candidates pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidates will be got re-examined for fitness from an authorized Medical Officer/ Practitioner.

- vii) Contractual appointee will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to the regular officials at the minimum of the pay scale.
- viii) Provisions of service rules like FR SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contractual appointee. She will be entitled to emoluments etc. as detailed at (i) above.

The Governor, Himachal Pradesh is further pleased to order the posting of above Assistant Professor (Management) on contract basis in Atal Bihari Vajpayee Govt. Institute of Engineering & Technology, Pragatinagar, Distt. Shimla. She is directed to report for duty at the place of her posting within 10 days positively on the receipt of this appointment letter, failing which it will be presumed that the incumbent is not interested and offer of appointment shall be deemed to be cancelled.
