## TERMS AND CONDITIONS FOR ENGAGEMENT

- 1. They will be paid consolidated remuneration @ Rs. 14100/- per month consolidated on contract basis under IMC of concerned ITI and @ Rs. 180/- per hour for Theory and Rs. 90/- per hour for Practical will be paid to the persons engaged on hourly basis under SWF (Maximum upto @ Rs. 14100/- P.M. consolidated) subject to work and conduct and availability of funds.
- Since IMC/SWF is not a Government body, this engagement will not entitle for appointment / regularization under any scheme of the State Government and their services shall automatically stand terminated on the completion of the mentioned trade / tenure. The mode of engagement is purely under SWF/IMC and will not be on employee of the Govt. and shall have no right of regularization. In case of any dispute arising between the Employees so engaged leading to litigation, the IMC will be authority to reply for all intents and purposes through Principal-cum Member Secretary of IMC for ITI/ Principal of the concerned Institution.
- 3. The Member Secretary –cum-Principal / Principal of the concerned Industrial Training Institution shall issue the engagement order and shall be the controlling officer and he/ she can also assign you other work in addition to your bonafide duties, relating to upliftment / betterment of IMC/Institute. He/ She will report your work and conduct annually/tenure wise to the undersigned.
- 4. He/ She will have to submit copies of your educational qualifications (Academic and Technical) to the office of the Member Secretary -cum-Principal ITI/ Principal of the concerned Institute.

- He/ She will have to submit medical certificate of your fitness from the competent authority to the Member Secretary -cum-Principal ITI / Principal of the concerned Institution.
- 6. He/ She will have to submit character certificate from the competent authority to the Member Secretary –cum-Principal ITI/ Principal of the concerned Institution.
- If married, she will have to submit undertaking that you have only one living spouse to the Member Secretary –cum-Principal ITI / Principal of the concerned Institution on the proper paper.
- No TA/DA shall be paid for joining the said assignment.
- He/ She will be entitled to one Casual leave after putting one-month service.
- 10. The engagement is also liable to termination in case his/ her work and conduct and moral turpitude are not found satisfactory by the IMC at any time even before the completion of the course with a notice of 10 days. If they have to leave the assignment, a notice of 10 days will be required from you so that arrangement for suitable incumbent could be made.
- 11. The Engagement Shall be subject to the outcome of OA 1318/2017 Sanjay Kumar & Others V/s State of HP & Others, OA 5005/2018 titled as Arun Kumar s/o Sh. Vijay Kumar Vs Union of India & Ors. and OA 5019/2018 titled as Duni Chand Vs. State of HP & Ors. Further it is also intimated that the engagements will not be covered under Govt. Notification No. EDN(TE)B(1)2/2015 dated 3rd October 2015.
