## ORDER

The Instant case arises from Orders of the Hon'ble HPAT in O.A. No.1116/2019 titled as Shri Desh Raj Sharma Vs State of HP and ors. dated 20-03-2019. The Hon'ble HPAT in its order has stated that –

> "In the facts and circumstances and interest of justice, the original applications is disposed of with the stipulation that subject to the applicant making a fresh detailed representation, supported by documents alongwith certified copy of this order, highlighting the above aspects and with a request for transfer against an existing/likely vacancy, to respondent No.1, through the Pr. Secretary (TE) to the Govt. of H.P. within a week from today, who shall consider and decide the same in accordance with law, sympathetically, and the transfer policy framed by the State Govt, By 31st May, 2019, after affording an opportunity of being heard to the applicant as well as private respondent No. 2".

> Both the parties (Sh. Desh Raj Sharma, HOD (Mech. Engg.) and Sh.

September, 2019. Both were heard personally by the undersigned. Sh. Desh Raj Sharma who is serving at G.P. Kangra since 27-03-2015 has been agitating for

posting at Government Polytechnic Hamirpur to look after his mother (suffering from various old age problem). While Shri Arvind Katoch cited his health condition. for posting at Hamirpur (his home town). He has also submitted his medical papers. Sh. Desh Raj will retire on 30-09-2024. He stated that he has never served his home district i.e. Hamirpur during the entire service while the second applicant Sh. Arvind Katoch has been serving at his Home district (Hamirpur)

Arvind Katoch, HOD (Mech. Engg.) were called for personal hearing on 6th

since 2001 almost 18 years of his service. Sh. Katoch is retiring on 2029. Keeping in view the aforesaid points and the retirement policy of Government it is directed

that Sh. Desh Raj Sharma, HOD (Mechanical) may join at the place of Sh. Arvind

Katoch i.e. Government Polytechnic Hamirpur and Sh. Arvind Katoch may join at Kangra in the place of Sh. Desh Raj Sharma i.e. Kangra.
