**ORDER**

Whereas Sh. Sachin Sharma, S/o Sh. Mahender Lal, Village Dari, P.O. Chail Chowk, Tehsil Chachyot, District Mandi, HP was appointed as Principal, ITI vide Notification No. EDN(TE)B(2)7/2016, dated 25<sup>th</sup> July, 2016 on the basis of the recommendations received from the Himachal Pradesh Public Service Commission.

Whereas a Legal Notice dated 29.7.2016, issued by Sh. Vijay Chaudhary, Advocate on behalf of his client namely Sh. Sunny Duggal alongwith copy of the order dated 8.7.2016 passed by the Hon'ble Himachal Pradesh Administrative Tribunal in O.A. No. 3308/2016, was received in this Department on 3.8.2016.

Whereas a Contempt Notice dated 6.8.2016 passed in Contempt Petition No. 195 of 2016 in O.A. No. 3308/2016 received in this Department on 8.8.2016.

Whereas the record pertaining to said OA was searched and it was found that the O.A. No. 3308/2016 and its enclosures were not received in this office till 3.8.2016.

Whereas the said appointment orders of Sh. Sachin Sharma, S/o Sh. Mahender Lal issued on 25.7.2016 are found to be non-est, being in violation of the order dated 8.7.2016 passed by the Hon'ble Himachal Pradesh Administrative Tribunal in O.A. No. 3308/2016.

Therefore, the Notification No. EDN(TE)B(2)7/2016 dated 25.7.2016 in respect of Sh. Sachin Sharma, S/o Sh. Mahender Lal appearing at Sr. No. 16 of said Notification is hereby cancelled being in violation of the order of Hon'ble Himachal Pradesh Administrative Tribunal passed in O.A. No. 3308/2016 on 8.7.2016 received on 3.8.2016 and thus, non-est in the eyes of law. Further action will be taken as per the final outcome/decision of the Hon'ble Himachal Pradesh Administrative Tribunal in O.A. No. 3308/2016.


