a fee of Rs. 650/- at Govt. Polytechnic Hamirpur for participation in the spot counselling process. The desirous candidates fulfilling the eligibility criteria mentioned under chapter-4 of this prospectus may report to the Principal Govt. Polytechnic Hamirpur with all the original certificates and testimonials on 28-07-2016 before 11:30 AM positively. The admission to these vacant seats will be started w.e.f. 2:00 PM onwards on the same day and shall be based on the merit list so prepared of the received applications in the office of Principal Govt. Polytechnic Hamirpur.

4. Allotment of seats shall be available on the Himachal Pradesh Takniki Shiksha Board web site on the respective counseling dates and accordingly allotment letters have to be downloaded by the respective candidates.
5. The Director, Technical Education, H.P. reserves all rights to modify the schedule of counseling for admission subject to the exigency of situation.

Un-aided Private Institution Management should give an advertisement in at least two leading newspapers (Hindi and English Version) having widest circulation in the State and outside the State for inviting applications to make admissions on Management Quota seats and for seats remained vacant after last round of online counseling with clear-cut mention of minimum eligibility criteria as mentioned in Chapter-4 and last date for receipt of application form and schedule of counseling in the said advertisement.

- The applications should be invited strictly from those candidates who are having minimum eligibility qualification/criteria as prescribed in Chapter-4.
- Provisional Admission – There will be no provisional admission whatsoever either in regular diploma stream or at lateral entry level. (Auth – EDN (TE) E (1) 13 / 2010 dated 05-03-2012)
