1. Short Title and Commencement.

- (1) These Rules may be called the Himachal Pradesh Technical Education, Vocational & Industrial Training Department, Lecturer Engineering (Polytechnic), Class-1 (Gazetted), Recrumment and Promotion Rules, 2011.
- (2) These Rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

This concession will not, however, be admissible to such staff of the Public Sector Corporations/ Autonomous Bodies who were/are subsequently appointed by such Corporations / Autonomous Bodies and who are/were finally absorbed in the service of such Corporations /Autonomous Bodies after initial Constitution of the Public Sector Corporations/Autonomous Bodies.

15-A Selection for appointment to the post by contract appointment

Notwithstanding anything contained in these rules, contract appointments to the post will be made subject to the terms and conditions given below:-

(I) CONCEPT:-

(a) Under this policy the Lecturer Engineering (Polytechnic) in Department of Technical Education, Vocational & Industrial Training, Himachal Pradesh will be engaged on contract basis initially for one year, which may be extendable on year to year basis.

(b) POST FALLS WITHIN THE PURVIEW OF HPPSC:

The Principal Secretary / Secretary (Technical Education) to the Govt, of Himachal Pradesh after obtaining the approval of the Government to fill up the vacant posts on contract basis will place the requisition—with the concerned agency i.e. H.P.Public Service Commission.

(c) The selection will be made in accordance with the eligibility conditions prescribed in these Rules.

(II) CONTRACTUAL EMOLUMENTS:-

The Lecturer Engineering (Polytechnic) appointed on contract basis will be paid consolidated fixed contractual amount ② ₹ 21,000/- P.M. (which shall be equal to minimum of the Pay Band + GP). An amount of ₹ 630/- (3% of the minimum of Pay Band + GP of the post) as annual increase in contractual emoluments for the subsequent year(s) will be allowed if contract is extended beyond one year.

(III) APPOINTING / DISCIPLINARY AUTHORITY:-

The Principal Secretary / Secretary (Technical Education) to the Govt. of Himachal Pradesh will be appointing and disciplinary authority.

(IV) SELECTION PROCESS:-

Selection for appointment to the post in the case of Contract. Appointment will be made on the basis of viva-voce test or if considered necessary or expedient by a written test or practical test the standard/syllabus etc. of which will be determined by the concerned recruiting agency i.e. H.P.Public Service Commission.

(V) COMMITTEE FOR SELECTION OF CONTRACTUAL APPOINTEES:-

As may be constituted by the concerned recruiting agency i.e. H.P. Public Service Commission.

(VI) <u>AGREEMENT</u>:-After selection of a candidate, he/she shall sign an agreement as per Annexure-B appended to these rules.

(VII) TERMS AND CONDITIONS:-

- (a) The contractual appointee will be paid fixed contractual amount @ ₹21,000/- P.M. (which shall be equal to minimum of the Pay Band + Academic Grade Pay) P.M. An amount of ₹ 630/- (3% of the minimum of Pay Band + Academic Grade Pay of the post) for further extended years and not other allied benefits such as senior /selection scales etc., will be given.
- (b) The service of the Contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- (c) Contract Appointee will be entitled for one day casual leave after puring one month's service. This leave can be accumulated up to one year. No leave of any other kind is admissible to the contract appointee. He/she shall not be entitled for Medical Re-imbursement and LTC etc. only maternity leave will be given as per rules.
- (d) Unauthorized absence from the duty without the approval of the controlling Officer shall automatically lead to the termination of the contract. Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.
- (e) An official appointed on contract basis who have completed rive years tenure at one place of posting will be eligible for transfer on need bases basis wherever required on administrative grounds.
- (f) Selected candidate will have to submit a certificate of his their titness from a Government / Registered Medical Practitioner. Women candidate, pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be re-examined for the fitness from an authorized Medical Officer Practitioner.
- (g) Contract appointee will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular appointee at the minimum of the pay scale.
- (h) Provisions of service rules like FRSK, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc., as are applicable in case of regular employees will not be applicable in case of contract appointees. They will be entitled for emoluments etc., as detailed in this Column.

16. Reservation

The appointment to the service shall be subject to orders regarding reservation in the service for Scheduled Castes/Scheduled Tribes/ other Backward Classes /other categories of persons issued by the Himachal Pradesh Government from time to time.

7. Departmental Examination

Every member of the service shall pass a Departmental Examination as prescribed in the Departmental Examination Rules, 1997 as amended from time to time.

18. Power to Relax:

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing and in consultation with the H.P. Public Service Commission, relax any of the provisions of these Rules with respect to any class or category of persons or posts.
