ORDER

The case was called on 21.08.2023 by issuing notices to the Appellant and PIO. The PIO-cum-Joint Director was present. The Appellant was not present. The information supplied to the Appellant by the PIO was perused. It appears that information which was available with the PIO has been supplied to the appellant as per the provisions contained in the Act. As the appellant has asked questions like "Please give the reason for not giving notional benefit to Sh. Jag Pravesh in Directorate O/o No. 2317 dated 31/12/2018 his initial appointment was as a Trainer Engg. Drawing in Govt. ITI Chopal on 23/12/11 and presently working in Govt. ITI Theog as a Instr. Math & Drg. But as per RTI Act the said information is not covered under section 2 (f) of the same which says that "information" means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force. Only that information has to be given which is available on record. Therefore, contention of the appellant that the information sought has not been supplied to her is not found to be correct. Accordingly, there is no merit in this appeal and the same is ordered to be dismissed.
