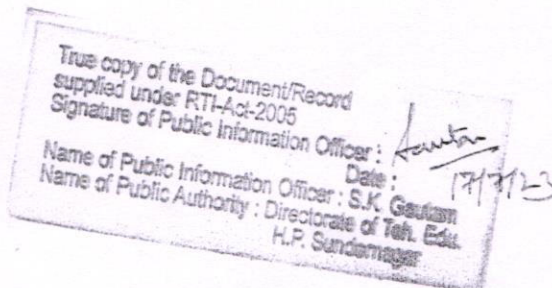

Kindly refer to your office letter No.EDN(TE)B(2)1/2005-Loose dated 04-04-2019, EDN(TE)B(3)1/2019 dated 04-04-2019, EDN(TE)B(2)15/2013 dated 04-04-2019 & EDN(TE)B(4)1/2014 dated 16-04-2019 on the subject cited above. In this connection, it is submitted that the concerned Principals were directed by this office to re-examine the cases of dependents of the deceased employees of their Institutes in accordance with the Finance Department's Office Memorandum No. Fin-F-(A)-(16)-1/2013 dated 07-03-2019 and to re-submit the same to this office. In addition to the revised cases from the concerned Principals, 02 new cases were also received from dependents of deceased employees namely Mr. Yesh Sharma S/O Late Sh. Rajeev Kumar & Miss Anjali D/O Late Sh. Amar Singh for providing employment on compassionate grounds to them. Late Sh. Rajeev Kumar father of Mr. Yesh Sharma had served in this Directorate as Driver and Late Sh. Amar Singh father of Miss Anjali had served as Clerk at Govt. Pharmacy College, Rohru.

A Committee has been constituted at Directorate level to examine the said cases in accordance with the Finance Department's Office Memorandum No. Fin-F-(A)-(16)-1/2013 dated 07-03-2019. The Committee has examined the cases and submitted its report (copy enclosed) wherein applicants namely Sh. Hitesh Kumar S/O Late Sh. Bachitter Singh, Smt. Neelam W/o Late Sh. Shyam Lal and Ms. Anjali D/o Sh. Amar Singh are found eligible for consideration for employment to the post of Clerk on compassionate ground. However, the applicants namely Sh. Suresh Kumar S/O Late Sh. Rattan Singh, Sh. Ravinder Kumar S/O Late Sh. Pyare Lal and Sh. Yesh Sharma S/O Late Sh. Rajeev Kumar do not full-fill the income criteria and they are ineligible for consideration for appointment to the post of Clerk on compassionate ground. The applications alongwith documents as supplied by the dependents of deceased through concerned Principals are enclosed herewith in original for your information and sympathetic consideration please.

It is further submitted that the above mentioned employees were serving in this Department and expired during their services. Hence, the cases for providing employment to the post of Clerk on compassionate grounds are being sent to the Govt. As

pe. instructions issued vide Govt. notification dated 7/3/2019 in enclosed Annexure-A under point -8 ( C) the ceiling of 5% posts direct recruitment vacancies for making compassionate appointment should not be exceeded by utilizing any other vacancy e.g. sports quota vacancy etc. It is submitted that 5% posts of Clerk meant for employment on Compassionate grounds are already filled-up in this Department.

It is pertinent to mention that as per the instructions issued by Finance Department vide Office Memorandum dated 07-03-2019 in enclosed Annexure-A under point-03 the Administrative Department shall be competent to make the compassionate appointment, subject to fulfillment of all essential conditions and satisfaction as to the indigent circumstances of the family of the deceased/retired Govt. servant.

Keeping in view of above, it is requested that the approval for appointment on compassionate grounds in respect of Sh. Hitesh Kumar S/O Late Sh. Bachitter Singh, Smt. Neelam W/o Late Sh. Shyam Lal and Ms. Anjali D/o Sh. Amar Singh may kindly be accorded with the permission to appoint the said candidates over & above the 5% posts meant for compassionate grounds or these candidates may be sponsored to other Departments to the post of Clerk on compassionate grounds.

Moreover, the necessary directions in the remaining cases of Sh. Suresh Kumar S/O Late Sh. Rattan Singh, Sh. Ravinder Kumar S/O Late Sh. Pyare Lal and Sh. Yesh Sharma S/O Late Sh. Rajeev Kumar who do not fulfill the income criteria may also be given to this office please.
