### TERMS AND CONDITIONS:

1. They shall furnish the agreement and undertaking duly attested by the Competent Authority before their joining.
2. The contractual appointee will be paid fixed contractual amount @ Rs. 8150/-P.M. (which shall be equal to the Pay Band +Grade Pay+150% of Grade Pay). The contract appointee will be entitled for annual increase of Rs. 186/- (3% of the minimum of the Pay Band +Grade Pay) for further extended year and no other allied benefits such as senior/selection scales etc. will be given.
3. They shall remain engaged on contract basis for period of one year after which their engagement shall automatically cease to be effect i.e. their services shall automatically stand terminated unless the contract is renewed subject to satisfactory work and conduct. No separate intimation of their services shall be given to them.
4. The services of the contract employee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
5. They will be entitled for one-day casual leave after putting in one month's service. However, the contract employee will also be entitled for 10 days Medical Leave and 5 days special leave. They shall not be entitled for Medical Re-imburement and LTC etc. No leave of any kind except above is admissible to the contract appointee. Provided that the un-availed Casual Leave and Medical Leave can be accumulated up to the Calendar Year and will not be carried forward for the next Calendar Year.
6. Unauthorized absence from duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. The Contract employee shall not be entitled for contractual amount for the period of absence from duty.
7. The candidate appointed on contract basis and has completed three years tenure at one place of posting, can be transferred on need based basis wherever required on administrative grounds.
8. The selected candidates will have to submit a certificate of their fitness from a Government/Registered Medical Practitioner.
9. A selected candidate shall have to produce the educational qualification certificate, character certificate, Bonafide Himachali Certificated at the time of their joining.
10. The contractual employee will be entitled to TA/DA, if required to go on tour in connection with their official duties at the same rate as applicable to regular counterpart official at the minimum of the pay scale.
11. In case, they intends to leave the engagement or employment they shall give at least one month notice to that effect (specifying the date) and obtain a proper relieving letter from the Head of the Institute concerned.
12. Provisions of Service Rules like FR SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of the contract appointee.
13. The Group Insurance Scheme as well as EPF/GPF not be applicable to them.
14. The Service rendered on contract shall not be counter toward qualifying and pensioner benefits etc.
