

TERMS AND CONDITIONS:

1. He/She shall have to produce a Medical Fitness Certificate of his/her fitness duly signed by the Medical Officer of the Govt. Hospital indicating specifically that he/she is not suffering from any communicable disease.
2. He/she is liable to produce the original certificates of academic qualifications, age proof, character, etc. in original at the time of joining the post.
3. He/she is liable to serve anywhere in Himachal Pradesh.
4. The appointment is purely on daily waged basis and liable to terminated at any time by serving a month notice from either side viz the appointee or their appointing authority.
5. He/she is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to him/her for the last three years before joining the appointment.
6. If any declaration given or information furnished/supplied by him/her proves to be false or found to have willfully suppressed, his/her services will be terminated and appropriate action as the Govt. may deem fit.
7. A declaration to this effect that candidates have not/shall not have more than one living wife/husband.
8. No TA/DA will be allowed for joining the duty.
