The above officials shall be on probation for 02 years. The above Officials are hereby directed to join their respective place of posting within **10 days** failing which the promotion shall stand forfeited for the next one year and they shall continue at their present place of posting as their cadre i.e. Class-IV.

Note: As per the provision contained in the R&P Rules the above Officials will have to qualify the typing test with a minimum speed of 30 W.P.M. in English or 25 W.P.M. in Hindi typewriting during the probation period which will be conducted by this Directorate and the incumbents will get three chances. If the candidate fails to qualify the typewriting test within the prescribed period, their probation period will be extended for one year. During the extension period the incumbent will get more one chance. If the candidate still fails to qualify the typing test in the extended period, they will be reverted from JOA (IT) to respective Class-IV post(s).

Above said official mentioned at Sr. No. 02, who has been deployed from other Institute is hereby repatriated to his respective Institute with immediate effect .
