**And whereas,** the Govt. vide letters No. PER(AP)C-B(2)-1/2019 dated 21-02-2019, 22-04-2020 & 30-03-2021 has instructed that the services of contractual appointees who are completing three years of continuous services as on 31-03-2019 and 30 09-2019, 31-03-2020 and 30-09-2020 & 31-03-2021 and 30-09-2021 shall be regularized after these dates i.e. 31-03-2019 and 30-09-2019, 31-03-2020 and 30-09-2020 & 31-03-2021 and 30-09-2021 and further, the Govt. vide letter No. PER(AP)C-B(2)-1/2019 dated 28-12-2021 has instructed that the services of

contractual appointees who are completing two years of continuous services as on 30-09-2021 shall be regularized after these dates i.e. 30-09-2021.

Therefore, keeping in view the aforesaid instructions issued by the Govt. vide letter dated 21-02-2019, 22-04-2020, 30-03-2021 & 28-12-2021 the benefit of regularization in favour of aforesaid incumbents are hereby allowed on notional basis w.e.f. the dates mentioned herein under in col. No. 6 after taking into consideration their services rendered on contract basis as Craft Instructors w.e.f. the dates mention in col. No. 4 and on actual basis from the date on which they have actually joined their services on regular basis.
