#### Background:-

The Directorate of Technical Education, Vocational and Industrial Training, Himachal Pradesh at Sundernagar is having the Administrative Control of its functional units in the State. The Department of Technical Education, Vocational & Industrial Training is responsible for providing Technical Education, Vocational & Industrial Training in the State at various levels i.e.

ITI- Craftsmen Trade Course for skilled workers / technicians.

Polytechnics - Diploma Courses for middle level engineers.

Engineering/Pharmacy Colleges:- Undergraduate/Post-Graduate in Engineering and Technology/Pharmacy

The department of Technical Education in compliance to directions issued by the Hon'ble High Court of Himachal Pradesh under CWPIL No. 12/2019- Court on its own motion Vs State of HP & ors. intends to empanel accessibility auditing agencies for auditing various infrastructures of the Engineering Colleges/Polytechnic/Pharmacy/ITIs.

#### Scope of work:-

To conduct access audit in the designated locations and submit a report of the infrastructures as per provisions of the Rule 15 of the Right of Persons with disability act.

The access audit is to be done in 104 (approx.) Institutions including hostel, toilets, gallery, parking, pathways, canteens, entry and exit etc.

# Eligibility, Terms and conditions for the empanelment of Agencies for conduct of access audit

#### Eligibility:-

The agency should qualify for the eligibility criteria and possess the required experience, resources and capabilities in providing services necessary to meet the requirements indicated in the Expression of Interest document. The agencies not meeting the necessary criteria will not be considered for further evaluation.

The Agency should be a registered body under relevant acts and having an auditor empanelled by Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities to Govt. of India. Empanelment of the agency will be valid for a

period of 5 years, unless extended by the Directorate of Technical Education, Vocational and Industrial Training, Himachal Pradesh at Sundernagar. An access audit team must comprise the members as mentioned in the Office Memorandum dated 06.11.2024 issued by the Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities to Govt. of India.

The access audit is to be carried out as per the guidelines and standards issued by Department of Empowerment of Persons with Disabilities (Divyangjan) Government of India, Ministry of Social Justice & Empowerment, New Delhi.

#### Terms and Conditions:-

- 1. The agency should adhere all the instructions and submit all the relevant information and documents which has been specified in EOI. The submissions of the application which are not complying instructions will result in rejection.
- 2. The agency should not be blacklisted in last one year by any Central/State government/Public Sector Undertakings.
- 3. The agency shall bear all cost associated with preparation and submission of the application and all cost, if any, for subsequent selection process. The department will in no case be responsible or liable for these costs regardless of conduct or outcome of this selection process.
- 4. Amendments to this EOI may be issued by the department at the time, prior to the deadline of the submission. Such amendments will be posted in <a href="https://techedu.hp.gov.in">https://techedu.hp.gov.in</a> website in form of addenda/corrigenda. The amendments issued shall be deemed to form an integral part of EOI from the date of issue and shall be binding on the agencies. The department reserves right to accept or reject any proposal and annul the EOI process and reject all applications at any time prior to empanelment of agencies and reserve the right to reissue the EOI without the agencies having right to object such reissue.
- 5. The empanelment does not guarantee allocation of work. No documents or reports shall be published without consent of the department.

#### **Evaluation Method:-**

The department will examine the application to determine whether the documents

submitted are complete, whether the required information has been provided as per the EOI, whether the documents have been properly signed and complied the requirements. Only those agencies which comply with the eligibility criteria will be taken for further evaluation.

The Evaluation process to consider whether the agency has experience and expertise conduct the access audit. Minor infirmities, non-conformities may be waived at the discretion of the department. The department will evaluate the applicants for the empanelment of agencies and will prepare a result on performance parameters and information furnished in the application.

The evaluation committee's decision will be final.
