ORDER

WHEREAS, the petitioners in CWP No. 3993/2021-Jitender Singh Rangta and Ors. V/s State of HP & others, and CWP No. 987/2021 titled as Ashraf Ali V/s State of HP & others were allowed promotion to the post of Group Instructor from retrospective dates i.e. with effect from the dates of availability of vacancy and their attaining the eligibility as per R&P Rules, 1987 in compliance with the order/judgment dated 07/04/2025 passed by the Hon'ble High Court of Himachal Pradesh and subsequent approval conveyed by the Govt. vide letter No. EDN(TE)E(1)18/2025 dated 07/07/2025, vide this office order No. 1727 dated 22/07/2025.

WHEREAS, Feeling aggrieved by the action of the Department in restricting the benefit of promotion to the post of Group Instructor from retrospective dates only to the petitioners in the aforesaid CWPs, several officials have filed multiple writ petitions seeking the same relief as granted by the Hon'ble High Court of Himachal Pradesh in CWP No. 3993/2021 titled Jitender Singh Rangta and Others vs. State of HP & Others and CWP No. 987/2021 titled Ashraf Ali vs. State of HP & Others. These petitions include CWP No. 13380/2025 titled Anoop Singh and Others vs. State of HP & Another, CWP No. 13698/2025 titled Kashmir Singh vs. State of HP & Another, CWP No. 13746/2025 titled Sudesh Kumar vs. State of HP & Another, CWP No. 14713/2025 titled Gian Chand and Others vs. State of HP & Another, CWP No. 15361/2025 titled Anil Kumar and Others vs. State of HP & Another, CWP No. 15117/2025 titled Satish Kumar vs. State of HP & Another, and CWP No. 16076/2025 titled Jugal Kishore vs. State of HP & Another.

WHEREAS, all of the aforementioned CWPs have been decided/ disposed of by the Hon'ble High Court of Himachal Pradesh. The CWP No. 13380/2025-titled Anoop Singh and others has been Decided/Disposed of vide judgment dated 21/08/2025, the operative part of the judgment is as under:-

"5. Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition is disposed of with direction to respondent No.2/competent authority to consider and decide the aforesaid representations of the petitioners dated 24.07.2025 (Annexure P-4 Colly.) in accordance with law as well as taking into consideration the above decision in Jitender Singh Rangta within a period of six weeks from today. The decision so

arrived at shall also be communicated to the petitioners. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

The CWP No. 13698/2025-titled Kashmir Singh Vs. State of HP & Another and CWP No. 13746/2025-titled Sudesh Kumar Vs. State of HP & Another have been Decided/Disposed of vide judgments dated 26/08/2025 & 27/08/2025 respectively, the operative part of the judgments is as under:-

"4. Accordingly, the petition is disposed of with directions to respondent No. 2 to consider and decide the case of the petitioner within a period of eight weeks, in light of judgment passed by the Coordinate Bench of this Court in CWP No. 3993 of 2021, titled as, Jitender Singh Rangta & others vs. State of H.P. & another, decided on 7.4.2025 along with connected matter. Needless to say that in case the petitioner is found similarly situated, as the petitioner in CWP No. 3993 of 2021, he shall also be granted the benefits as have been granted to the petitioners in CWP No. 3993 of 2021. Pending miscellaneous applications, if any, also stand disposed of."

The CWP No. 14713/2025-titled Gian Chand & others Vs. State of HP & Another has been Decided/Disposed of vide judgment dated 11/09/2025, the operative part of the judgment is as under:-

"7. Accordingly, the present petition is disposed of with a direction to the respondents/competent authority to consider and decide the case of petitioner, within a period of six weeks from today, in light of Jitender Singh Rangta supra as well as rules occupying the field, at the relevant time. Needless to say, authority concerned, shall afford opportunity of hearing to the petitioners and pass a speaking order thereafter. Liberty is reserved to the petitioners to file appropriate proceedings in appropriate court of law, if they still remain aggrieved. Pending application(s), if any, also stands disposed of."

The CWP No. 15361/2025-titled Anil Kumar & others Vs. State of HP & Another, has been Decided/Disposed of vide judgment dated 23/09/2025, the operative part of the judgment is as under:-

"4. Consequently, in view of the above, the present petition is disposed of with a direction to the respondents to consider and decide the case of the petitioners in light of aforesaid judgment expeditiously, preferably within a period of three weeks. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioners and pass appropriate orders thereupon. Liberty is reserved to the petitioners to file appropriate proceedings in appropriate Court of law, if they still remain aggrieved. Pending application(s), if any, also stands disposed of."

The CWP No. 15117/2025-titled Satish Kumar Vs. State of HP & Another, has been Decided/Disposed of vide judgment dated 19/09/2025, the operative part of the judgment is as under:-

"3. Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to

consider and decide the representation of the petitioner (Annexure P-4) in light of aforesaid judgment expeditiously, preferably within a period of six weeks from today. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon. Pending application(s), if any, also stands disposed of."

The CWP No. 16076/2025-titled Jugal Kishore Vs. State of HP & Another, has been Decided/Disposed of vide judgment dated 14/10/2025, the operative part of the judgment is as under:-

"2. Petitioner's grievance is that his representation Annexure P-4 dated 25.7.2025 annexed with this writ petition, seeking applicability of Jitender Singh Rangta and others versus State of H.P and another.2 has not been decided till date by the respondents/competent authority. Learned counsel for the petitioner submitted that the petitioner would be content, in case, respondents/competent authority are directed to consider and decide the aforesaid representation of the petitioner, in accordance with law, within a time bound manner. Learned Additional Advocate General has no objection to this prayer. Having regard to the above submissions, but without examining the merits of the matter, this writ petition is disposed of by directing the respondents/competent

AND WHEREAS, keeping in view of the directions of the Hon'ble High Court issued in the aforesaid CWPs, the meeting of the Departmental Promotion Committee (DPC) was conducted on **29-10-2025**, in the office of the Director, Technical Education, Vocational and Industrial Training, HP at Sundernagar. During the DPC review meeting, the Committee recommends that the minutes of the Departmental Promotion Committee (DPC) meetings held on 30.12.2014, 06.06.2015, 23.09.2020, and 26.06.2025, pertaining to the consideration of eligible Craft Instructors for promotion to the posts of Group Instructor-Class III (Non-Gazetted), be suitably modified to this extent **restricting the consequential financial/monetary benefits only to the original petitioners in CWP No. 3993/2021 titled Jitender Singh Rangta & Others and CWP No. 987/2021 titled Ashraf Ali vs. State of H.P. & Others**, with the prior approval of the Government. Accordingly the matter was referred to the Govt. vide this office letter No. 66840 dated 29/10/2025. Consequently, the Government vide letter No. **EDN(TE)E(1)18/2025** dated **06/12/2025** conveyed the approval.

NOW, THEREFORE, in view of the above order/directions of the Hon'ble High Court and subsequent approval of the Govt., and in supersession of Order No. 1727 dated **22/07/2025**, the petitioners in CWP No. 3993/2021-Jitender Singh Rangta and Ors. V/s State of HP & others, and CWP No. 987/2021 titled as Ashraf Ali V/s State of HP & others, along with other aggrieved officials in the cases mentioned

above are hereby allowed to be promoted as Group Instructor, as per the details mentioned below:-
