## NOTIFICATION

Whereas, the Hon'ble High Court HP has issued the following directions to the respondents vide its orders/judgment passed by the Hon'ble High Court Himachal Pradesh in CWP NO. 3837 of 2020 decided on 22.12.2020 titled as Lalit Mohan and others Versus State of Himachal Pradesh & another, CWP No. 5343 of 2020 decided on 16.12.2020 titled as Sonam Bodh and others Versus State of Himachal Pradesh & another, CWP No. 5438 of 2020 and decided on 30.12.2020 titled as Satish Kumar and others Versus State of Himachal Pradesh & another, Execution Petition 23/2021- decided on 02.03.2021 tilted as Lalit Mohan and others Versus State of Himachal Pradesh & another and COPC 72/2021 decided on 16.03.2021 titled as Satish Kumar and others Versus State of Himachal Pradesh & another:

"...In aftermath, the writ petition is allowed, and, the apposite order borne in Annexure P-9 is quashed and set uside, and, the respondent(s) shall, in accordance with the roster points hence fixed for the relevant purpose, forthwith ensure meetings, of, promotion(s), to the writ petitioners from the post of group instructors, to the promotional post, of, Principal(s), ITIs concerned."

And whereas as per directions of the Hon'ble High Court it had been decided vide Notification No. EDN (TE)E(1)33/2019 dated 25/03/2021 to withdraw the notification No. EDN (TE)E(1)33/2019 dated 06.11.2020 till the final outcome of the DPC and thereby maintained the status quo of promotion orders regarding promotion of Group-Instructors to the post of Principal ITIs issued vide Notifications No. EDN (TE) A (3) 24/2015-I dated 09.10.2018 and 19.05.2020.

And whereas, accordingly the review DPC was conducted on 28,04,2021 in the office of Himachal Pradesh Public Service Commission, Shimla-2. In the review DPC meeting the Committee observed that there is no change in the Seniority list of Group Instructors, list of eligible Group Instructor for promotion to the post of Assistant Director/Principal ITI (Class-I Gazetted), in the Department of Technical Education, Vocational & Industrial Training, Himachal Pradesh and also observed that there is no change in zone of consideration, roster, grading of APRs, recommendations of earlier DPCs held on 19,09,2018 and 11,05,2020 and order of merit and came to the conclusion that there is no need to review the minutes of the meeting of aforesaid DPCs. Thus, the Committee didn't recommend any change in minutes of meeting of DPCs held on 19,09,2018 and 11,05,2020;

Now therefore, promotion orders of Group Instructor for promotion to the post of Principal ITI (Class-I Gazetted), in the Department of Technical Education, Vocational & Industrial Training, Himachal Pradesh as per recommendation of earlier DPCs held on 19.09.2018 and 11.05.2020, issued vide Notifications No. EDN (TE)A(3)24/2015-I dated 09.10.2018 and 11.05.2020 respectively are hereby restored and bring into force.
