OFFICE ORDER


In pursuance to the instructions issued by the Department of Personnel to the Government of Himachal Pradesh vide letter No. PER(AP)C-B(2)-1/2014-V.II dated 28-03-2022, Directorate office order No. 3259 dated 17/12/2022, whereby the services of **Smt. Kavindra Kumari, Instructor, SOT (Embroidery), Govt. Industrial Training Institute, Chachiot, Distt. Mandi** have been taken over on Government contract basis w.e.f. 25/02/2020 on notional basis after completion of 07 years/9600 hours of services rendered under IMC/SWF & now, on the recommendations of the Departmental Service Committee constituted at Directorate level, the services of **Smt. KavindraKumari, Instructor, SOT (Embroidery), Govt. Industrial Training Institute, Chachiot, Distt. Mandi** appointed on Contract Basis are hereby regularized after taking into consideration her 02 years continuous contractual services (as on 31-03-2022) with immediate effect and further posted at **Govt. Industrial Training Institute, Chachiot, Distt. Mandi**. Her pay shall be fixed at the **1st cell of pay matrix i.e. level-11 plus other allowances** as admissible from time to time subject to the terms and conditions mentioned below;

TERMS AND CONDITIONS:

1. She shall have to produce a Medical Fitness Certificate of her fitness duly signed by the Chief Medical officer/Medical Officer of the area, before joining to the post.
2. She shall have to produce the original certificates of her academic/technical qualifications, age proof, character, etc. in original at the time of joining the Post.
3. She is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices /Institutions.
4. She shall have to take an oath of Allegiance/Faithfulness to the Constitution of India.
5. Regularization of services can be terminated at any time by giving one month notice or by paying a sum equivalent to salary of one month, for a period by which the period of notice fall short of one month by either side, without assigning any reason or if any discrepancy comes to the notice at a later stage. The appointing authority, however, reserves the right of termination the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to her of a sum equivalent to the pay and allowances for the period of notice fall short of one month.
6. She is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to her for the last three years before joining the appointment.
7. She shall have to submit a declaration to the effect that she has one living spouse, if married.

8. If any declaration given or information furnished/ supplied by her proves to be false or she is found to have willfully suppressed any material/ information she will be liable for removal from the service and for such action as the Govt. may deem fit.
9. The services rendered on contract basis shall not be counted towards qualifying service and pensionary benefits etc. She shall be entitled to regular scale of pay and seniority as **Craft Instructor** from the date of her joining on regular basis.
10. The official shall be on probation for a period of two years which can be extended, if so warranted.
11. The appointment shall be governed under Himachal Pradesh Civil Service Contributory Pension Rule, 2006.
12. The appointee shall have to submit the nomination of the Group Insurance Scheme, 1984 at the time of joining of duty.
13. No TA/DA will be admissible for joining the duty.

If the offer is acceptable to her on the terms and conditions mentioned above, she may join service at her place of posting within 15 days from the issue of these orders failing which the offer shall be treated as withdrawn.
