OFFICE ORDER

Consequent upon the issuance of the regularization orders issued by the Deputy Director of Higher Education, Kinnaur Distt. Kinnaur at Reckong Peo vide Office Order No. EDN-KNR-(2)A(4)44/2018 dated 08/03/2022, Deputy Director of Higher Education, Distt. Bilaspur vide Office Order No. EDN-HE-BLS(B)(2)9/2020-22523-529 dated 28/03/2022 & Office Order No. EDN-HE-BLS(B)(2)9/2020-23048-051 dated 20/04/2022, whereby the following PTWC cum daily wagers, who completed 11 years of continuous service (i.e. 07 years as PTWC + 04 years as Daily Wagers) as on 30/09/2021 and who have been regularized as Class-IV in the Cell-1 of Level-1 of the pay matrix of HPCS (RP) Rules, 2022 with the minimum start of Rs. 18000/- plus other allowances as per and approval accorded by the Secretary (TE) to the Govt. of Himachal Pradesh vide office letter No. EDN(TE)B(2)08/2019 dated 23-06-2022, are hereby adjusted/posted in the Technical Education Department as per details appended below:-

TERMS AND CONDITIONS:

1. He/She shall have to produce a Medical Fitness Certificate of his/her fitness duly signed by the Medical Officer of the Govt. Hospital indicating specifically that he/she is not suffering from any communicable disease.
2. He/She is liable to produce the original certificates of his/her academic/technical qualifications, age proof, character, etc. in original at the time of joining the post.
3. He/She is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices/ Institutions.
4. The appointment may be terminated at any time by giving one month notice either side viz. the appointee or appointing authority, without assigning any reason. The appointing authority however reserves the right of termination of the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her of sum equivalent to the pay and allowances for the period of notice of the un-expired portion thereof.
5. He/She is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to his/her for the last three years before joining the appointment.
6. He/She has to submit a declaration to the effect that he/she has only one living spouse, if married.
7. He/She will have to submit an undertaking in writing that he/she is not convicted by any Court of law.
8. He/She will have to submit an oath of allegiance to remain faithful to the constitution of India.
9. No TA/DA will be admissible for joining the new place of posting on regularization.
10. If any declaration given or information furnished/supplied by his/her proves to be false, or he/she is found to have willfully suppressed any material/information, he/she will be liable for removal from the service and for such action as the Govt. may deem fit.
11. The services rendered on Daily Wages basis shall not be counted towards qualifying services and pensionary benefits, etc. He/she shall be entitled to regular scale of pay and seniority as Class-IV from the date of his/her joining on regular basis.
12. The official shall be on probation for a period of two years, which can be extended, if so warranted.

13. The appointment shall be governed under Himachal Pradesh Civil Service Contributory Pension Rules, 2006.

14. The candidates who do not full-fill the educational qualifications criteria as per R&P Rules of the post will not be eligible for further promotion.

If the officials are willing to accept the offer on the terms and conditions mentioned above, he/she should report for duty to the concerned institute within 15 days from the issuance of this order failing which the offer shall be treated as cancelled.




