In compliance to the judgment passed by the Hon'ble High Court, Himachal Pradesh on dated 23/05/2022 in CWP No. 3552/2020 titled as Manju Rani Vs State of HP and Ors. and approval conveyed by the Govt. vide letter No. EDN(TE)E(1)-26/2022 dated 06/07/2022, **Sh. Pin code 176047** is hereby engaged as Trainer Computer Operator & Programming Assistant (COPA) under Institute Management Committee (Self Financed Scheme) purely on full time basis as stop-gap arrangement for one academic session i.e. August, 2022 in the Department of Technical Education, Vocational and Industrial Training, Himachal Pradesh, with immediate effect subject to the following terms and conditions:-

TERMS AND CONDITIONS FOR ENGAGEMENT

1. He will be paid consolidated remuneration @ Rs. 16,215/- per month on contract basis under IMC of concerned ITI and subject to work and conduct and availability of funds.
2. Since IMC is not a Government body, this engagement will not entitle him for appointment / regularization under any scheme of the State Government and his services shall automatically stand terminated on the completion of the mentioned training / tenure. The mode of engagement is purely under IMC and he will not be the employee of the Govt. and shall have no right of regularization. In case of any dispute arising between the Employee so engaged leading to litigation, the IMC will be authority to reply for all intents

and purposes through Principal-cum Member Secretary of IMC for ITI/ Principal of the concerned Institution.

3. The Member Secretary –cum-Principal / Principal of the concerned Institution shall be the controlling officer and he can also be assigned other work in addition to his bonafide duties, relating to upliftment / betterment of IMC/ Institute. He will report his work and conduct annually/ tenure wise to the undersigned.
4. He will have to submit copies of his educational qualifications (Academic and Technical) to the office of the Member Secretary –cum-Principal ITI/ Principal of the concerned Institute.
5. He will have to submit medical certificate of his fitness from the competent authority to the Member Secretary –cum-Principal ITI / Principal of the concerned Institution.
6. He will have to submit character certificate from the competent authority to the Member Secretary –cum-Principal ITI/ Principal of the concerned Institution.
7. If married, he will have to submit undertaking that he has only one living spouse to the Member Secretary –cum-Principal ITI / Principal of the concerned Institution on the proper paper.
8. No TA/ DA shall be paid for joining the said assignment.
9. He will be entitled to one Casual leave after putting completion of one month service.
10. The engagement is also liable to termination in case the work and conduct and moral turpitude are not found satisfactory by the IMC at any time even before the completion of the course with a notice of 10 days. If he has to leave the assignment, a notice of 10 days will be required from him so that arrangement for suitable incumbent could be made.
11. **The Engagement Shall be subject to the outcome of OA 1318/2017 Sanjay Kumar & Others V/s State of HP & Others, OA 5005/2018 titled as Arun Kumar s/o Sh. Vijay Kumar Vs Union of India &Ors and OA 5019/2018 titled as Duni Chand Vs State of HP & Ors. Further, it is also intimated that his engagement will not be covered under Govt. Notification No. EDN(TE)B(1)2/2015 dated 3rd October 2015.**

If the above term and conditions are acceptable to him for the engagement as **Trainer(s) in relevant trade as mentioned above as shown against his name**, then he may submit the attached undertaking duly countersigned by the Executive Magistrate along with his joining report on or before 03/08/2022.
