TERMS AND CONDITIONS:

- He/She shall have to produce a Medical Fitness Certificate of his/her fitness duly signed by the **Medical Officer** of the Govt. Hospital indicating specifically that he/she is not suffering from any communicable disease.
- 2. He/She is liable to produce the original certificates of his/her academic/technical qualification, age proof, character, etc. in original at the time of joining the post.
- 3. He/She is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices/ Institutions.
- 4. The appointment may be terminated at any time by one month notice given by either side viz. the appointee or appointing authority, without assigning any reason. The appointing authority however reserves the right of termination of the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her of sum equivalent to the pay and allowances for the period of notice of the un-expired portion thereof.
- 5. He/She is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to his/her for the last three years before joining the appointment.
- 6. He/She has to submit a declaration to the effect that he/she has only one living spouse, if married.
- 7. If any declaration given or information furnished/supplied by his/her proves to be false, or he/she is found to have wilfully suppressed any material/information, he/she will be liable for removal from the service and for such action as the Govt. may deem fit.

The services rendered on Daily Wages basis shall not be counted 8. towards qualifying services and pensionary benefits etc. He/she shall be entitled to regular scale of pay and seniority as Class-IV from the date of his/her joining on regular basis.

The official shall be on probation for a period of two years, which can 9.

be extended, if so warranted.

The appointment shall be governed under Himachal Pradesh Civil 10. Service Contributory Pension Rules, 2006.

- The seniority shall be fixed as per the office order of the Deputy 11. Director, (Higher Education) Sirmour at Nahan as per letter referred above.
- The candidates who does not full-fill the educational qualifications 12. criteria as per R&P Rules of the post will not be eligible for further promotion.

If the officials are willing to accept the offer on the terms and condition mentioned above, he/she should report for duty to the concerned institute on or before 03/02/2020 from the issue of this order failing which the offer shall be treated as cancelled.
