TERMS AND CONDITIONS:

- He/she shall have to produce a Medical Fitness Certificate of his/ her fitness duly signed by the Chief Medical officer/Medical Officer of the area, before joining to the post.
- He/she shall have to produce the original certificates of his/her qualifications, age proof, character, etc. in original at the time of joining the Post.
- He/she is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices /Institutions.
- 4. He/she shall have to take an oath of Allegiance/Faithfulness to the Constitution of India.
- Regularization of service can be terminated at any time by giving one month notice or by paying a sum equivalent to salary of one month, for a period by which the period of notice fall short of one month by either side, without assigning any reason or if any discrepancy comes to the notice at a later stage. The appointing authority however reserves the right of termination the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice fall short of one month.
- He/she is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to him/her for the last three years before joining the appointment.
- He/she shall have to submit a declaration to the effect that he/she has one living spouse, if married.
- 8. If any declaration given or information furnished/ supplied by him/her proves to be false or he/she is found to have willfully suppressed any material/ information he/she will be liable for removal from the service and for such action as the Govt. may deem fit.
- 9 The services rendered on contract basis shall not be counted towards qualifying service and pensionary benefits etc. He/she shall be entitled to regular scale of pay and seniority as **Class-IV** from the date of his/her joining on regular basis.

- The officials shall be on probation for a period of two years which can be extended, if so warranted.
- 11. The appointment shall be governed under Himachal Pradesh Civil Service Contributory Pension Rule, 2006.
- The appointee shall have to submit the nomination of the Group Insurance Scheme, 1984 at the time of joining of duty.
- 13. No TA/DA will be admissible for joining the duty.

If the offer is acceptable to the candidates on the terms and conditions mentioned above, he/she may join service at his/her place of posting within 15 days from the issue of these orders failing which the offer shall be treated as withdrawn.
