**TERMS & CONDITIONS OF APPOINTMENT ARE AS UNDER:-**

1. He/She will have to produce a Medical Fitness Certificate from the authorized Medical Officer at the time of joining the post.
2. He/She has to submit a declaration to this effect that he/she has one living spouse, if married.
3. He/She has to take an oath of allegiance/faithfulness to the Constitution of India in the prescribed form.
4. He/She will have to produce the original certificates and attested copies of his/her educational/professional qualifications and proof of date of birth certificate, duly signed by him/her at the time of joining the post.
5. He/She will have to submit a bonafide Himachali Certificate issued by the Executive Magistrate/ Sub Divisional Magistrate.
6. He/She will have to submit the Character Certificate from a Gazetted Officer to whom he/she is known for the last two years.
7. He/She will have to furnish a declaration to the effect that he/she is not a dismissed employee of any Govt./Semi. Govt. Department/Organization

8. He/She will have to give in writing, whether he/she was ever convicted by any criminal court or any departmental proceeding/vigilance case is not pending against him/ her.
9. He/She will have to submit category certificate to which he/she belongs issued by the competent authority.
10. No. T.A. will be allowed for joining the post.
11. The appointment may be terminated at any time by issuing one month notice given by the Competent Authority without assigning any reason thereof. The undersigned, however, reserves the right of terminating his/her services forthwith or before the expiry of the stipulated period of notice by making payment to a sum equivalent to the pay and allowances for the period of notice of un-expired portion thereof.
12. He/She will have to submit assets and liabilities return immediately on his/ her joining on the post.
13. He/She will have to carry out the duties and responsibilities of Clerk or any other additional duties assigned to him/her by the Head of Office from time to time.
14. He/She will be on probation for 02 years as per rules in the first instance. Further his/ her services will continue subject to his/her work and conduct being found satisfactory.
15. If any declaration given or information furnished by him/her is proved to be false later on, he/she will liable to be removed from service or any such other action as the Government may deem necessary will be taken against him/her.

If the offer of appointment is acceptable to the candidate, then he/she should report to his/her place of posting within 15 days from the issuance of these orders failing which the offer of appointment shall stand cancelled.
