
**Subject: - Regarding Advisory for Educational Institutions.**

Sir/Madam,

This is with respect to decision taken by Hon'ble Cabinet on 09/04/2021 and in continuation to this office letter No. STV(TE)H-F(5) Misc. information-2019-27097-27120 dated 06/04/2021 already addressed to your good office on the subject cited above. In this connection, it is intimated that:-

1. All Educational Institutions, in Government Sector as well as in Private Sector, including teaching and non-teaching staff, shall remain closed till 21<sup>st</sup> April 2021, exams to continue as per present practice.
2. Principal/Head of Institutes will not leave the station without prior approval of the undersigned.
3. All the Head of Educational Institutions are authorized to call the Teaching and Non-teaching staff to perform the essential duties, if any. Further in view of ongoing examination of Engineering and B.Pharmacy Colleges, ITIs, the Head of institute may call the employees with proper justification of work assigned to the concerned Teachers/Non-Teaching staff.
4. The online classes of the students will be continued as per previous practice.
5. Principals/Head of the Institutions may direct the ministerial staff to attend the office as per requirement.
6. However in case of ITIs, since deposit of fee is still going on/pending, ministerial staff should invariably be directed to attend the institute.
