TERMS AND CONDITIONS:

- 1. She shall have to produce a Medical Fitness Certificate of her fitness duly signed by the Chief Medical Officer/Medical Officer, before joining to the post.
- 2. She is liable to serve anywhere in Himachal Pradesh in the Technical Education Department wherever the Department has or may have offices /Institutions.
- She shall have to take an oath of allegiance/faithfulness to the Constitution of India.
- 4. The appointment may be terminated at any time by one month notice given by either side viz. the appointee or appointing authority, without assigning any reason. The appointing authority however reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to her of a sum equivalent to the pay and allowances for the period of notice of the un-expired portion thereof.
- 5. She is required to produce a certificate of character issued by Sub Divisional Magistrate or from the Gazetted Officer known to her for the last three years before joining the appointment.
- 6. She shall have to submit a declaration to the effect that she has one living spouse, if married.

- If any declaration given or information furnished/ supplied by her proves to be false or is found to have willfully suppressed any material/ information she will be liable for removal from the service and for such action as the Govt. may think necessary.
- 8. The services rendered on contract basis shall not be counted towards qualifying service and pensionery benefits etc. She shall be entitled to regular scale of pay and seniority as Steno Typist from the date of her joining on regular basis.
- The above officials shall be on probation for a period of two years which can be extended, if so warranted.
- 10. The appointment shall be governed under Himachal Pradesh Civil Service Contributory Pension Rules, 2006.
- 11. The appointee shall have to submit the nomination of the Group Insurance Scheme, 1984 at the time of joining of duty.

If, the offer is acceptable to her on the terms and conditions mentioned as above, she may join duty at her place of posting within 15 days from the issue of these orders failing which the offer shall be treated as withdrawn.
