Whereas Shri Atul, Lecturer (Applied Sciences & Humanities) Chemistry was appointed on contract basis vide Notification No. EDN(TE)B(2)1/2015 dated 25.03.2015 in the Department of Technical Education Vocational & Industrial Training and he joined his duties on 09.04.2015(A.N.).

Whereas said Shri Atul, Lecturer (Applied Sciences & Humanities) Chemistry, presently working in Government Polytechnic Kullu has requested for acceptance of his resignation from the service due to his appointment as Assistant Professor (Chemistry) in Higher Education Department.

Whereas being contract appointee, matter of resignation and subsequent acceptance thereof is inconsequential.

Therefore, on the basis of above position, contract services of Shri Atul, as Lecturer (Applied Sciences & Humanities) Chemistry stand terminated w.e.f. 10.03.2017 (AN), subject to condition that all the outstanding amount, if any recoverable, shall be deducted from the dues payable to him.
