**Memorandum**

Whereas, Sh. Ankush Bharti, Lecturer (Physics) was transferred from Govt. Polytechnic (W) Kandaghat to Govt. Polytechnic, Kinnaur camp at Rohru vide Notification No. EDN(TE)B(6)3/2020, dated 22.12.2021. Aggrieved with said transfer order Sh. Ankush Bharti has filed CWP No. 8107/2021 before the Hon'ble High Court. Hon'ble High Court vide order dated 21.03.2022 has dismissed the petition as withdrawn and has directed that *in case the petitioner moves a representation before the respondents, for redressal of his grievance within one week from today, then the same shall be disposed of by the respondents within two weeks thereafter, in accordance with Law.*

And whereas in compliance to the directions of the Hon'ble High Court, before deciding the representation of Sh. Ankush Bharti, personal hearing was given to him on 05.04.2022. During the course of personal hearing, Sh. Ankush Bharti expressed willingness for his adjustment at either of the vacant stations i.e. Govt. Polytechnic, Banikhet or Govt. Polytechnic, Kinnaur camp at Rohru. As per his request he was adjusted at Govt. Polytechnic, Banikhet, Distt. Chamba vide this Department's order No. EDN(TE)E(1)14/2019 dated 11.04.2022. But it is a matter of great concern that even giving the suitable adjustment as per his choice he is exerting the political pressure for further adjustment at his choice of station which is becoming of government servant and violation of Rule 20 of the CCS (Conduct) Rules, 1964, which provides as under:-

**“No Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service under Government.”**

And whereas it is pertinent to mention here that Sh. Ankush Bharti had obtained stay from Hon'ble High Court of Himachal Pradesh citing political influence, and on the other hand during the currency of the stay orders, he himself procured U.O. Notes for adjustment of choice of station from the office of Hon'ble Chief Minister and Hon'ble Technical Education Minister. The detail of U.O. notes procure by Sh. Ankush Bharti for his choice of posting is as under:-
