MEMORANDUM

Subject: Revised tentative Seniority list of Assistant Professor (Electronics and Communication Engineering) Government Engineering Colleges of Technical Education Vocational & Industrial Training Department as on 30.11.2024 in compliance of judgement dated 03.08.2023 passed by Hon'ble High court in CWP Taj Mohammad Vs State of H.P.

Some of the officers of the Technical Education Department have filed CWPs before the Hon'ble High Court of Himachal Pradesh on the basis of judgement delivered in the lead case i.e. in CWP No. 2004/2007-Taj Mohammad Vs State of H.P. to grant them seniority from the date of their initial recruitment on contract basis. To comply the judgement/ orders of the Hon'ble High Court passed in various cases filed by the officers of Technical Education Department and representations received from non-petitioners.

On the basis of above judgement M/s Priyanka Nagu, Sh. Ajay Kumar, Sh. Harish Kumar, Sh. Prateek Kumar, Sh. Anil Pundir, Sh. Vineet Mehta, Sh. Sachin & Others had also filed CWPs to grant benefit of contract services. These matters were taken up with the Advisory Departments alongwith the Advocate General State of Himachal Pradesh. The Advocate General has advised

"After disposal of the Taj Mohammad case it is advised to grant them seniority and consequential benefits like promotions from prospective date."

In compliance to the above advice and the Hon'ble High Court in its orders issued on different dates has given directions to scrutinize the case of these officers in the light of the judgement delivered vide which the Hon'ble Court that the services rendered by the applicants on contract basis were liable to be counted for the purpose of seniority.

Consequent upon this, a lot of changes are likely to occur in the seniority position of the incumbents as assigned to them in the final seniority lists as circulated vide this department memorandum. Besides a lot of changes have also taken place due to promotion/induction of new incumbent(s) in the cadre.

Accordingly, a fresh tentative seniority of Assistant Professors indicating the position as it stood on 30.11.2024 has been prepared and annexed herewith as Annexure-and is circulated for information of the concerned officer(s). The objections/representations, if any, may be submitted to the undersigned within a period of 30 days from the dated of issuance of this Memorandum.
