"After disposal of the Taj Mohammad case it is advised to grant them seniority and consequential benefits like promotions from prospective date."

In compliance to the above advice and the Hon'ble High Court in its orders issued on different dates has given directions to scrutinize the case of these officers in the light of the judgement delivered vide which the Hon'ble Court that the services rendered by the applicants on contract basis were liable to be counted for the purpose of seniority.

Consequent upon this, a lot of charges are likely to occur in the seniority position of the incumbents as assigned to them in the final seniority lists as circulated vide this department memorandum. Besides a lot of changes have also taken place due to promotion/induction of new incumbent(s) in the cadre.
