In pursuance to judgement dated 28.08.2024 in CWP No. 8459 of 2022 titled as Akshay Sharma V/s State of Himachal Pradesh & Ors. passed by Hon'ble High Court, H.P. and this Department's notification No. EDN(TE)B(1)2/2015 dated 03-10-2015, further clarification dated 21-10-2015, the Governor of Himachal Pradesh is pleased to take over the services of Sh. Akshay Sharma, Assistant Professor (Textile Engineering) appointed under Students Welfare Fund in, Jawaharlal Nehru Engineering College Sundernagar, District Mandi, H.P. as Assistant Professor (Textile Engineering) on contract basis, w.e.f 30.08.2018 in the Department of Technical Education Vocational & Industrial Training, Himachal Pradesh, further he is posted at Jawaharlal Nehru Government Engineering College Sundernagar, District Mandi, H.P, on the terms and conditions depicted below:-

**TERMS AND CONDITIONS:-**

- i) The above contractual appointee will be paid fixed contractual amount @ Rs. 35000/- P.M. No other allied benefits such as senior /selection scales etc. will be given.
- ii) The services of the above contractual appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- iii) He will be entitled to one day's casual leave after putting one month service. However, he will also be entitled for 10 day's Medical Leave and 5 days special leave. He shall not be entitled for Medical Re-imbursement and LTC etc. No leave of any kind except above is admissible to the above contractual appointee. Provided that the un-availed Casual Leave and Medical Leave can be accumulated up to the Calendar Year and will not be carried forward for the next Calendar Year.
- iv) Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. The above contractual appointee shall not be entitled for contractual amount for the period of absence from duty.
- v) The above official appointed on contract basis who has completed two years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.

- vi) The candidate will have to submit a certificate of his fitness from a Government/Registered Medical Practitioner.
- vii) Contract appointee will be entitled to TA/DA if required to go on tour in connection with his official duties at the same rate as applicable to the regular officials at the minimum of the pay scale.
- viii) Provisions of service rules like FR SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. They will be entitled to emoluments etc. as detailed at (i) above.

He is directed to report for duty at the place of his posting within 10 days positively on the receipt of this appointment letter, failing which it will be presumed that the incumbent is not interested and offer of appointment shall be deemed to be cancelled.
