- The services of the above contractual appointee will be purely on temporary basis. The ii) appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- He will be entitled to one day's casual leave after putting one month service. However, iii) he will also be entitled for 10 day's Medical Leave and 5 days special leave. He shall not be entitled for Medical Re-imbursement and LTC etc. No leave of any kind except above is admissible to the above contractual appointee. - vii) Contract appointee will be entitled to TA/DA if required to go on tour in connection with his official duties at the same rate as applicable to the regular officials at the minimum of the pay scale.
- viii) Provisions of service rules like FR SR, Leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. They will be entitled to emoluments etc. as detailed at (i) above.
