## **NOTIFICATION**

The Governor, Himachal Pradesh is pleased to order to regularize the services of Sh. Navdeep Sharma, Assistant Professor (Computer Science and Engineering) appointed on contract basis, as per the instructions issued by the Department of Personnel, Government of Himachal Pradesh vide letter No. PER(AP)-C-B(2)-1/2019, dated 28.12.2021 w.e.f. 01.10.2021 in the pay scale of Rs. 57,700/- (Level-10, Cell-I) notified by this Department vide notification no. EDN(TE)B(2)-27/2022 dated 10.10.2022, on the terms and conditions depicted below:-

## TERMS AND CONDITIONS:-

- 1. No TA/DA will be paid to him for joining the post.
- 2. Original certificate of academic/technical qualifications, age, character etc. in original at the time of joining will be produced by the candidates.
- 3. The appointment may be terminated at any time by one month's notice given by either side viz. the appointment or the appointing authority without assigning any reason. The appointing authority however reserves the right of terminating the services of the appointees forthwith on or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice of the un-expired portion thereof.
- 4. A Character Certificate issued by the Sub Divisional Magistrate or from Gazetted officers known to them for the last three years before joining the appointment will be produced by the candidates. The candidate(s) shall give declaration that they have got only one living spouse, if married.
- 5. If any declaration given or information furnished/supplied by the candidate(s) proves to be false or he is found to have willfully suppressed any material information he will be liable for removal from service and for such other action as the Government may think fit.
- 6. He shall be liable to serve in any part of Himachal Pradesh in the Technical Education Department, wherever the Department has officers/institutions. or may have
- He shall be governed by the rules, regulations and orders in force from time to time
  as are applicable to other Government servants such as CCS (CCA) Rules, 1965 and
  CCS (Conduct) Rules, 1964.

- 8. He shall remain on probation for a period of 2 years in the first instance from the date of his joining. The probation period can be extended by the competent author for one year by assigning reasons in writing under the provision of the Rules.
- The service rendered on contract basis shall not be counted towards qualifying service. He shall be entitled to regular scale of pay and seniority from the date of his/her regularization.
- 10. He shall have to produce a Medical fitness Certificate of his fitness duly signed by the Medical Officer of the Government Hospital indicating specifically the he is not suffering from any communicable disease.
- 11. The officer will have to pass the departmental examination for further promotion.
- 12. His pay on the post will be fixed as per Rules.

If offer of appointment on the above terms & conditions is acceptable to them, they may join within a period of one week after completing all the codal formalities failing which the offer shall stand cancelled.
