NOTIFICATION

In pursuance to implementation of Pradhan Mantri Skilling and Employability Transformation through Upgraded ITIs (PM-SETU) guidelines issued by the Ministry of Skill Development and Entrepreneurship (MSDE), Government of India, vide Office Memorandum No. DGT-11011/2/2023-O/o DIR (SCHEMES) dated 20.11.2025 and in compliance with the requirement to constitute a *State Steering Committee (SSC)* as per these Guidelines, the Governor of Himachal Pradesh is pleased to constitute the *State Steering Committee (SSC)* for effective implementation, monitoring, and oversight of the Scheme at the State level.

1. Composition of the State Steering Committee (SSC)

The Chief Secretary to the Government of Himachal Pradesh shall be the **Chairperson** of the SSC. The composition shall be as follows:-

2. Roles and Responsibilities of the SSC

The State Steering Committee shall:

1. Provide overall strategic direction and ensure State-level coordination for the Scheme.

2. Review and recommend cluster-level *Strategic Investment Plans (SIPs)* submitted by Special Purpose Vehicles (SPVs).
3. Approve the *Annual Operational Plan (AOP)* for implementation of the Scheme in the State.
4. Facilitate inter-departmental convergence, synergy, and coordination among stakeholders.
5. Monitor scheme implementation, review achievement of key performance indicators (KPIs), and resolve operational bottlenecks.
6. Ensure timely release of the State's share of funds and promote effective industry participation.
7. Engage with industry and academia to strengthen training delivery, modernize curriculum, and enhance placement linkages.
8. Submit periodic progress reports, funding requests, and policy feedback to the *National Steering Committee (NSC)*.
9. Support the rollout of digital platforms, technology adoption, and capacity-building initiatives under the Scheme.

The SSC shall meet at least **once every quarter**, or more frequently, as deemed necessary by the Chairperson, to review progress and monitor the implementation of the scheme.


