The Governor, Himachal Pradesh is further pleased to notify the terms and conditions in respect of Board of Governors as under: -

- 1. The Board shall ordinarily meet not less than four times during a calendar year.
- 2. The meetings of the Board shall be convened by the Chairperson.
- 3. The one-third members amongst the notified members of the Board shall form the quorum.
- 4. The members of the Board shall be entitled to such allowances, if any, and the sitting fee from the University as may be provided in the Regulations.
- 5. The term of a nominated member of the Board shall be three years form the date of his nomination.
- 6. The Ex-officio member shall continue to be a member so long as he holds the Office by virtue of which he is the member of the Board.
- 7. Any vacancy in the Board occurring before the next reconstitution or before the expiry of the prescribed period shall be filled in the same manner as provided in sub-section (1) of Section 16 of the Act ibid and such a member shall hold office for the remainder of the terms of the member in whose place he is nominated.

- 8. The member shall be eligible for re-nomination for the next term.
- 9. Any member may resign from his office by writing under his hand addressed to the Chairperson of the Board and his resignation shall take effect from the date, it is accepted by the Chairperson of the Board.
