NOTIFICATION

In pursuance of this Department's notification No. EDN(TE)B(1)-2/2015 dated 03.10.2015, further clarification dated 21.10.2015 and on the recommendation of the Director (Technical Education), the Governor, Himachal Pradesh, is pleased to order to take over the services of following candidates who were engaged under Students Welfare Fund in the Department of Technical Education as Lecturer (Electrical Engineering) and (Electronics & Communication Engg.) on contract basis initially for a period of one year which may be extendable on year to year basis, in the Department of Technical Education Vocational & Industrial Training, Himachal Pradesh, in the following order:-

The above appointments to the post of Lecturer (Electrical Engineering) and (Electronics & Communication Engg.) in the Department of Technical Education Vocational & Industrial Training, Himachal Pradesh is subject to the terms and conditions specified in the R&P Rules of said post, instructions issued by the Govt. from time to time and terms and conditions depicted below:-

TERMS AND CONDITIONS :-

- The Lecturer appointed on contract basis will be paid fixed contractual amount which shall be equal to minimum of the pay band + grade pay and 150% of grade pay applicable to the post and as amended by the Finance Department from time to time. An amount of Rs. 630/- (3% of the minimum of pay band + grade pay of the post) as annual increase in contractual emoluments for the subsequent year(s) will be allowed, if contract is extended beyond one year.

- ii) The service of the Contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
- iii) The Contract Appointee will be entitled for one day's casual leave after putting in one month's service. However, they will be entitled for 10 days medical leave and five days special leave. He shall not be entitled for medical re-imburement and LTC etc. No leave of any other kind except above will be admissible to the above appointee.
Provided that the un-availed Casual Leave and Medical Leave can be accumulated upto the Calendar Year and will not be carried forward for the next Calendar Year.
- iv) Unauthorized absence from the duty without the approval of the controlling Officer shall automatically lead to the termination of the contract. He shall not be entitled for contractual amount for the period of absence from duty.
- v) The above contract appointee will be eligible for transfer after completion of three years tenure at one place of posting on need based basis whenever required on administrative grounds.
- vi) The above contract appointee will have to submit a certificate of his fitness issued by Medical Board.
- vii) The above contract appointee will be entitled to TA/DA if required to go on tour in connection with his official duties at the same rate as applicable to regular counterpart official at the minimum of pay scale.
- viii) Provisions of service rules like FR,SR, Leave Rules, GPF Rules, Pension Rules & Conduct rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. The Employees Group Insurance Scheme as well as EPF/GPF will also not be applicable to the contract appointees
- ix) The above contract appointees shall sign Contract Agreement as prescribed in the R&P Rules of said post.
- x) Other conditions of service shall be governed by the relevant Rules and orders as amended from time to time.

The candidates will submit their joining within 10 days positively on the receipt of this appointment letter alongwith required documents, failing which it will be presumed that the incumbent is not interested and offer of appointment shall be deemed to be cancelled.
